They should prove income from abroad. The applicant is allowed to have a Cyprus company, be only the shareholder and receive dividends. When can someone apply	Depending on the country of origin they can apply for entry permit and then for the work permit or they can enter with visitor/Schengen visa and then apply for the work permit	The applicant should enter with visitor/Schengen visa and then apply. CY bank account is necessary.	We can apply on behalf of the applicant while abroad. We will need signed documents certified by the CY embassy. If the applicant is in Cyprus we will certify the documents by a certifying officer in Cyprus
Personal Documentat ion (non- exhaustive list)	Brief Curriculum Vitae - CV (including copies of academic qualifications and or relevant professional experience of at least two years). Original Certificate of Criminal Record from the country of origin (if the applicant resides in a country other than the country of origin, the certificate should be issued from the country of residence).	Original letter of guarantee issued by a bank or cooperative institution in Cyprus with validity of 10 years covering possible repatriation expenses. The amount depends on the country of origin.
