Main applicant requirements



Applicants must be 18 years or older with a clear background



Clean criminal record; restricted nationalities include Russia, Belarus, Iran, North Korea



Good health is required; a medical exam is part of the process

- 1 Engage Dobda as your authorized agent
- 2 Dobda guides document preparation (passport copies, police clearances, medical certificates)
- 3 Sign client agreement; pay retainer fee
- 4 Submit application to IMA Grenada via Dobda
- 5 Attend mandatory virtual interview (applicants aged 16+)
- 6 IMA conducts due diligence via international firms
- 7 Receive Approval in Principle
- 8 Finalize investment (NTF donation or real estate purchase)
- Obtain Certificate of Registration; apply for passport(s)
