

Main applicant requirements


- We welcome applicants aged 18 and above with a clear background.
- Applicants must successfully pass a mandatory virtual interview.
- Good health is required; a medical exam is part of the process.

Investment Options

- Sustainable Island State Contribution (SISC):
 - Min. USD 250,000 (non-refundable) for a single applicant.
- 2 Real Estate Purchase:
 - Min. USD 325,000 in an approved project (hold for 7 years).
- 3 Private Home Purchase:
 - Min. USD 600,000 for an approved private dwelling (hold for 7 years).
- 4 Public Benefit Option (PBO):
 - Min. USD 250,000 contribution to an approved public benefit project.







Procedures

The Citizenship by Investment Unit (CIU) meticulously reviews all applications. A mandatory virtual interview for the main applicant and dependents aged 16 and over is required to ensure the highest standards of due diligence.

- Dobda guides document preparation (passport copies, police clearances, medical certificates)
- Client agreement signed, retainer paid
- Application prepared & submitted to CIU via Dobda
- Mandatory virtual interview conducted (applicants 16+)
- CIU performs thorough due diligence checks
- Receive Approval in Principle
- Finalize qualifying investment & pay remaining fees
- Saint Kitts and Nevis Passport Issued
